A meeting of the Board of Directors ("Board") of the City of Memphis and Shelby County Community Redevelopment Agency was held on Thursday, November 7, 2024, at CRA. All Board Members were present. President, Andrew Murray, and General Counsel, Monice Hagler, were not in attendance, due to another commitment on behalf of the CRA.

- CRA is retaining one year of revenues for operations.
- Lawn maintenance and block crews are wrapping up for the season.
- Edgeview -the CRA should be able to make the latest payment without drawing from the line of credit at a higher interest rate.
- The CRA is consistently requesting due funds from the City and County on a regular basis in order to have a better view of CRA's cashflow.
- CRA is monitoring Admin and will begin reimbursing the Admin Account for the payroll expenses by transferring the required funds.
- Now that the FY 2022-2023 audit is finalized, the correct deferred amounts for County and City receivables will be reflected.
- We are still awaiting confirmation from Banks, Finley and White on the audit workbook formats, but the CFO is moving forward with the current audit workbook formats.
- Collections are based on when the CRA expects payment (September for the City and February for the County).
- Investment accounts show a negative balance left for the City and County TIF. The CFO will review accounts to determine the cause.
- There was a spike in payables due to the CRA receiving the Edgeview invoice.
- Board Member Cantor inquired of the balance in Account 1600-Interfund Due to Due From. The CFO provided an explanation.
- Board Member Cantor requested an update for line items regarding employee medical and life insurance. CFO Cole-Smith stated that "this is paid per payroll." Board Member Cantor also questioned why fringe benefits jumped in August. The CFO will provide a response.

Staff Jordan McKenzie gave a report on the one-time 'Own Your Block' event that took place on October 19, 2024 in the Uptown North Memphis community. CRA's Block Wellness crews and community volunteers, in conjunction with the City of Memphis and Mayor Young's Project Peace initiative, removed approximately five tons of trash over an 8-hour period. The event was shared on social media.

Staff Emma Turri presented on "Brownfield 101" including the State of Tennessee program for brownfield contaminations. She reported that CRA received a million-dollar brownfields coalition grant from the EPA last year for environmental assessments. The Memphis Brownfield Coalition, with the CRA's technical assistance, has targeted priority sites for testing. She did a refresh on what the grant is and how it is being used.

## I. CALL TO ORDER

Chairman Martin called the meeting to order at 8:40 a.m. A quorum was present.

Per Mr. Broy, the audited financial statements will be submitted to the State Comptroller shortly.

A question and answer session followed. Board Member Cantor commented that on page 12, third paragraph, the CRA resolution needs grammar clarification.

Chairman Martin called for approval of the acceptance of the CRA 2022-2023 Audit. Board Member Langston made a motion and Board Member Schaftlein seconded it. The official acceptance of the 2022-2023 Audit was approved by the Board. It was noted that Board Member Stewart was not present to vote.
